Determine whether you are **ELIGIBLE** and **READY** to expunge

### **AM I ELIGIBLE?**

- **My conviction resulted in jail time and/or probation, not prison time and parole.**
- If you are a **parolee**, you are not eligible for expungement but you can contact the Public Defender at 213/974-3057 for assistance with a "Certificate of Rehabilitation."

### **AM I READY?**

**To be ready, you must:**

- Not be serving a sentence.
- Not be on probation or parole (for any conviction).
- Not be charged with a crime.
- Have paid all court fines and fees (on this case).\*

**\*You should contact the court's fiscal office to make sure that all fees or fines have been paid.**

# EXPUNGEMENT

## An Introduction

This guide only deals with criminal convictions obtained in California. Other states, the military, and the federal government may have a similar procedure, but you must check with them to find out what is required. Try the adult probation department or the public defender's office for the county you were convicted in, the Judge Advocate General's Office (Navy), (Army), (Air Force) for military convictions, or the Federal

Defender's Office for federal convictions.

**Important Notice:** This guide is intended as an information tool to assist you with cleaning up your criminal record. If the Public Defender's office represented you in your criminal case(s), it may be able to assist you. In some counties, the Public Defender may help you even if it did not represent you in your case. If not, and your case is very complicated, you may wish to seek private legal counsel to assist you with "cleaning up" your record.



In California, section 432.7 of the Labor Code, states "No employer, ..., shall ask an applicant for employment to disclose, ..., information concerning an arrest or detention that did not result in conviction, or information concerning a referral to, and participation in, any ... diversion program, nor shall any employer seek from any source whatsoever, or utilize, as a factor in determining any condition of employment including hiring, promotion, termination, ..., any record of arrest or detention that did not result in conviction, .... Nothing in this section shall prevent an employer from asking an employee or applicant for employment about an arrest for which the employee or applicant is out on bail or on his or her own recognizance pending trial...."

So, for the purposes of this guide, we will concern ourselves with "convictions."

### Find Out the Details of Your Convictions

In order to begin cleaning up your criminal record, you first need to know what is on your criminal record. The court will require you to fill out forms. Whether you are requesting a dismissal or a Certificate of Rehabilitation, you will need to know the details of your convictions(s) in order to complete the forms. Also, certain details will affect whether you are eligible. There are several details you will need to know in order to accomplish your goals:

1. Your Case Number(s) [Sometimes called docket number.]
2. Your Date(s) of Conviction(s) [The date of your plea or verdict.]
3. The Code Name(s) and Section Number(s) you were convicted of violating.
4. Was there a "Verdict" or did you "Enter a Plea"? If you Entered a Plea, was it "Guilty" or "Nolo Contendere" (No Contest)?
5. Were you ordered to serve any time on "Probation"? If so, how long? [Formal and informal probation are treated the same.]
6. Were you ordered to pay any "Fines," "Restitution," or "Reimbursement"?
7. If you were sentenced to state prison, which one?
8. If you were sentenced to state prison, what date were you released?
9. If you were released on "Parole," what date did your parole end?

### Get a Copy of Your Criminal Records Information

Your criminal records information can be obtained from a variety of sources. Below is a list of the sources most commonly used.

1. Your court papers received at the time of conviction.

2. Your attorney, parole officer, probation officer, or contacts within the courts or law enforcement community. The Superior Court where you were convicted. They will only have information for convictions from that county and not other counties. You will need to make a copy of your order(s) of judgment.
3. The California State Department of Justice Criminal Records Division. They will have your criminal records information for the entire State of California. They are located at 4949 Broadway, First Floor Fingerprinting Office, Sacramento, California. Their phone number is (916) 227-3400. There is a fee, but you may be eligible for a fee waiver. You must provide written proof of your income. It may take several weeks for the record to arrive in the mail.

## What You Can Do

### Situation:

- **You were convicted of a misdemeanor and are still on probation.** Request early release from probation and file petition to have conviction dismissed. File a PC 1203.3 petition to have probation terminated early, and PC 1203.4 petition for expungement.
- **You were convicted of a misdemeanor and have successfully completed probation.** File PC 1203.4 petition for expungement.
- **You were convicted of a misdemeanor and were never given any probation at all.** File PC 1203.4a petition for expungement.
- **You were convicted of a felony and are still on probation.** Request early release from probation and file petition to have conviction reduced to misdemeanor and dismissed. File a PC 1203.3 petition to have probation terminated early. File a PC 17(b) petition to get felony reduced, and PC 1203.4 petition for expungement.
- **You were convicted of a felony and are done with probation and/or county jail time.** File petition to have conviction reduced and dismissed. File a PC 17(b) petition to get felony reduced, and PC 1203.4 petition for expungement.
- **You were convicted of a felony and were never given any probation at all and were sentenced to county jail.** File petition to have felony reduced to a misdemeanor and file petition to have conviction dismissed. File a PC 17(b) petition to get felony reduced, and PC 1203.4a petition for expungement.
- **You were convicted of a felony and were sentenced to state prison or under the authority of the California Department of Corrections.** File a petition for Certificate of Rehabilitation and Pardon. Contact the Public Defenders office at (213) 974-3057.

## Dismissals

If you were convicted of a misdemeanor or a felony and were not sentenced to state prison or under the authority of the California Department of Corrections you can petition for a dismissal. This means you were given county jail time, probation, a fine, or a combination of those three. If you are petitioning for a dismissal, the court upon proper motion, may withdraw your guilty or nolo contendere (no contest) plea, or verdict of guilt if you went to trial, and enter a not guilty plea. Then the court will set aside and dismiss the conviction. From that point forward, you are considered no longer convicted of the offense. Your record will be changed to show a dismissal rather than a conviction.

### Are You Eligible for a Dismissal?

1. If you were given probation, you have either completed it or obtained early release. If you violated your probation and it was either reinstated or revoked, then the court has discretion whether or not to grant you a dismissal.
2. If you were not given probation, it has been at least one year since the date of conviction.
3. You have paid all fines, restitution and reimbursement ordered by the court as part of your sentence.
4. You are not currently under arraignment for a new criminal offense (charges pending), nor are you on probation for another offense.

### **Some Convictions are Not Eligible for Dismissal**

If you were convicted of any of the following offenses you are not eligible for a dismissal: Vehicle Code Section 42001(b) which includes sections 2800, 2801 and 2803; Penal Code Section 261.5(d), 286(c), 288, 288a(c), 288.5 and 289(j).

### **Diversion**

If you were referred to a "diversion" program, your record will already be changed in one of two ways. If you successfully completed all of the diversion program requirements, your record should already be changed to show a dismissal. If you didn't complete your requirements or were not actually given diversion, then the conviction will be on your record.

### **Marijuana Possession Offenses**

If you were convicted of possession of marijuana for personal use then you do not necessarily need to get a dismissal for the offense. Under California Health and Safety Code Sections 11361.5 and 11361.7 all possession of marijuana for personal use convictions, after January 1, 1976, are erased from your record after two years. BE CAREFUL! The conviction cannot be for cultivation, sales or transportation. If it is, it will be on your record.

### **Juvenile Records**

Your Juvenile records *do* appear on your criminal record. Upon your 18<sup>th</sup> birthday, you are eligible to petition to have your juvenile records sealed. Once sealed, no one can gain access to them and they will be completely destroyed five years from the date of sealing.

Juvenile records are *not* automatically sealed upon your 18<sup>th</sup> birthday. You must affirmatively petition the juvenile court to have them sealed. You can do this by filing out a form and filing it with the juvenile court *in the county in which you were convicted*. Contact the juvenile court in the county you were convicted, and ask them to send you a copy of the form used in that county. Check to see if they have any special filing requirements such as additional photocopies or the need to serve copies of the petition on any government agencies, and get the correct information for filing by mail. Usually, there is no fee.

If you graduated from the Department of Corrections and Rehabilitation, Division of Juvenile Justice, your juvenile conviction(s) will have been dismissed as part of your graduation. If you do not petition to have your juvenile records sealed and destroyed, they will remain on your record until your 38<sup>th</sup> birthday, then they will be destroyed.

### **What Will a Dismissal Do?**

Once all of your convictions have been dismissed:

1. On questions by *Private Employers* if you are asked if you have ever been convicted of a crime, you must respond with "YES-CONVICTION DISMISSED."
2. On questions by *Government Employers or Government Licensing Applications* if you are asked if you have ever been convicted of a crime, you MUST respond with "YES- CONVICTION DISMISSED." In California, government employers and licensing agencies (except for police agencies and concessionaire licensing boards), will treat you the same as if you had never been convicted of any crime.
3. You will not be allowed to own or possess a firearm until you would otherwise be able to do so.
4. Your dismissed conviction(s) can still be used to increase your punishment in future criminal cases.
5. Your prior conviction(s) can still affect your driving privileges.
6. If you have been required to register as a sex offender as a result of a conviction, you have to make a different motion to the court in order to be relieved of this requirement. A dismissal will not relieve you of your duty to register as a sex offender.

### **Complete and File the Petition(s) and Fee Waiver(s)**

If you are filing a petition for reducing a felony or a petition for early release from probation or for a dismissal, you will need to call the Clerk of the Superior Court *for the county in which you were convicted*, and ask them for the following information:

1. Have them send you as many copies of their form (if they have one) as you have convictions in that county.
2. Ask if you need to submit additional photocopies of the petition, and how many?
3. Ask if their rules of court require you to serve copies of your petition on the district attorney and/or probation department?
4. Ask what the correct mailing address is for filing by mail?

Remember, you can only dismiss one conviction at a time. This means you will fill out a separate petition for each conviction that you want to dismiss, but you can file them all at the same time. If you are currently on probation, you will need to deal with that conviction first, then you can proceed with the others. Usually there is a fee to file a petition for dismissal with the court. However, fee waivers are available to people who cannot afford to pay.

### **File Your Petition(s) and Fee Waiver(s) With the Court(s)**

If you are filing a petition for reducing a felony or a petition for early release from probation or a dismissal, you will need to mail (or deliver in person) your filing materials to the Clerk of the Superior Court *for the county of your conviction(s)*.

Be sure to include any supportive materials such as letters of support, school diplomas and/or transcripts, and if applying for early release from probation, include a letter to the judge explaining why you feel you should be released from probation early. At the time you file your papers, the clerk will set a hearing date.

If required in your county, be sure to serve the district attorney and/or probation department.

You will be required to attend the hearing, although for 1203.4 and 1203.4a petitions you may not have to appear. If you are required to attend the hearing, **BE SURE TO ATTEND**. Be on time and dress conservatively. If your petition is granted, make sure to put the order in a safe place for your records.

### **If Your Petition(s) is Denied**

Don't despair! You may still be able to get your conviction(s) dismissed. After you receive the order from the judge denying your dismissal, you can either go to, or call, the Clerk at the courthouse to see if you can find out why the petition was denied and whether you can fix the problem and re-file.

When you speak with the clerk, **be respectful, and take notes. Follow the instructions** of the clerk, and be sure to **thank the clerk** for his/her help.

### **Certificate of Rehabilitation**

If you were sentenced to state prison or sentenced under the authority of the California Department of Corrections you are not eligible for a dismissal under Penal Code Section 1203.4 or 1203.4a. You may, however, be eligible for a Certificate of Rehabilitation. For eligibility and application requirements contact the Board of Prison Terms, 428 J Street, 6<sup>th</sup> Floor, Sacramento, CA 95814. If you are eligible, you must file a petition with the Superior Court where you were convicted. This is a lengthy process that may necessitate the assistance of a private attorney.

## What Is A "Rap Sheet"?

If you have ever been arrested in California and fingerprinted, you have a California rap sheet. A "rap sheet" is a record of your arrest and conviction history in California. Rap sheets are maintained by the Division of Criminal Justice Services (DOJ) in Sacramento. Each time you are arrested and fingerprinted, the police department sends a report of the arrest to DOJ. If you have been arrested before, DOJ adds the new information to your computer file; if not, a file is created for you. DOJ keeps track of arrests in California only: cases from other states and federal cases will not appear on your California rap sheet. The FBI keeps a complete list of your arrests in all states, and your DOJ file will have a notation of your FBI computer code number. The state and local courts send information to DOJ as well. After your case is over, the court contacts DOJ to report the outcome of the case. This information is also known as the "disposition" of the case. There are many possible dispositions which could appear on your rap sheet. Some common dispositions include "NOT CONVICTED," "DISMISSED," "ACQUITTED," and "CONVICTED." A conviction is generally a **guilty plea or a court's finding of guilty** for a "crime" or an "offense." Criminal convictions are determined by both the disposition of the case and the classification of the offense (infraction, felony, or misdemeanor). For example, if you receive a deferred entry of judgment based upon your guilty plea and successfully complete probation, your guilty plea will not be considered a conviction. You can have a conviction even though you never served time in jail. If you received probation, paid a fine, did community service, or received a conditional sentence (see p. 3), you had a conviction. The disposition entry on your rap sheet will contain information about the type of offense you were convicted of. The following **types of offenses** may appear on your rap sheet:

**1. Infraction:** A non criminal case for which the penalty may consist of a fine, but not imprisonment. Most infractions are traffic-related, but some common non traffic infractions include a first conviction for loitering in a transit facility and a first conviction for trespass. If you were convicted of an infraction, you were not convicted of a crime, but you were convicted of an offense.

**2. Misdemeanor:** A lesser criminal offense that may result in a fine and a maximum of six months imprisonment in state prison or county jail, unless a particular statute specifies a different punishment. Common misdemeanors include possession of small amounts of marijuana, disorderly conduct, and misdemeanor assault. Conviction of a misdemeanor offense is considered conviction of a crime.

**3. Felony:** A serious criminal offense punishable by imprisonment in the state prison for more than six months (although you may not serve any time in jail or prison) or death. Some common felony charges are possession with intent to sell controlled substances, burglary, robbery, arson, carjacking, felony driving under the influence with bodily injury to another person, and felony assault. Conviction of a felony is considered conviction of a crime.

**4. "Wobbler":** A "wobbler" is a criminal offense that can be classified as either a misdemeanor or a felony, thus it "wobbles" between these two categories of offenses. Common wobblers include driving under the influence, battery with serious bodily injury, petty theft, simple grand theft, and receiving stolen property. Conviction of a wobbler is considered conviction of a crime.

Following are other **special dispositions** that may appear on your rap sheet:

**1. Deferred Entry of Judgment:** If you are charged with certain drug offenses and meet certain criteria, such as no prior convictions for offenses involving controlled substances and the offense charged does not involve violence, you may be eligible, with the agreement of the prosecutor, for a deferred entry of judgment. If you plead guilty and waive the right to a speedy trial, the court defers judgment and sentences you to probation or treatment. If you successfully complete probation or treatment, your guilty plea will not be a conviction.

**2. Vacating or Setting Aside a Guilty Plea or Verdict:** The court may "set aside" or vacate a guilty plea or verdict after a successful appeal, upon fulfillment of all probation conditions, or when ever justice requires. This procedure enables you to apply for a Certificate of Rehabilitation, pardon, and expungement. However, your guilty plea or verdict is still considered a conviction, and must be disclosed on applications for public employment, public office, or occupational licensure.

**3. Pre-plea Drug Diversion:** The criminal proceedings are adjourned while you participate in a program involving counseling, drug testing, education, and possibly other conditions. Your criminal charges are dismissed upon successful completion of the program. However, if the court finds any one of the following, your charges will be reinstated:

- unsatisfactory performance in the program;
- lack of benefit gained from the program; or
- continued criminal activity.

If your criminal charges are reinstated, this disposition may result in a conviction. However, if you successfully complete a pre-plea drug diversion program and your charges are dismissed, it is as if you were never arrested. Therefore, you may indicate that you were not arrested or granted diversion, except in applications for law enforcement jobs.

**4. Conditional Sentence:** If you satisfy certain conditions, such as attending an alcohol or drug treatment program, you will be discharged and you will not be required to serve time in jail. Your guilty plea or verdict is still considered a conviction, and must be revealed on job applications and in employment interviews.

Another entry that may appear on your rap sheet is a "bench warrant." If you fail to appear on your assigned court date and a bench warrant is issued for your arrest, the court tells DOJ. The warrant is added to your record and will appear on your rap sheet. Remember: You will still have a DOJ record even if your case was dismissed, or if you were convicted but served no time in jail.

#### **Who Can See Your DOJ Rap Sheet**

Five categories of people and agencies are allowed to see a copy of your rap sheet::

- **Criminal justice and law enforcement agencies**

Police departments, courts, prosecutors and defense attorneys, parole and probation departments, and corrections officials have the right to review your rap sheet, including juvenile ward of the court adjudications, "expunged" cases, and, in some cases, "sealed" information.

- **Private and public employers**

Most employers do not have the right to see your rap sheet. But California law does allow some groups of employers to get a copy of your rap sheet when they are reconsidering whether to hire you. Any employer who fingerprints you as part of the hiring process will probably send your fingerprints to DOJ to obtain your rap sheet. Here is a partial list of employers in California who are allowed to send for your rap sheet:

- Nuclear power plants and public utilities;<sup>10</sup>
- Certain positions with supervision over minors;<sup>11</sup>
- Security organizations;<sup>12</sup>
- Financial institutions, such as banks and brokerage houses;<sup>13</sup>
- Child day care facilities;<sup>14</sup> and
- Private schools.<sup>15</sup>

Most public employers can request a copy of your rap sheet. These employers include local, state, and federal government agencies, such as police and fire departments, the California Department of Corrections, your local board of education, and the United States Postal Service, among many others.<sup>16</sup>

- **Occupational licensing agencies**

Hundreds of jobs (including barber, real estate broker, doctor, nurse, and taxi driver) require a state or municipal license. Often, the agency that issues an occupational license requires applicants to show that they possess "good moral character" before a license will be granted. For a few licenses, there are laws that bar ex-offenders from even applying. For this reason, some occupational licensing agencies will check your DOJ file when you apply for a license.<sup>17</sup>

- **Bonding agencies**

A bond is a kind of insurance policy that an employer takes out on an individual employee to protect the employer in case that employee steals from the employer or from its customers. The agencies that issue bonds can get your rap sheet when deciding whether to bond you.<sup>18</sup>



- **You**

You have the right to see your own rap sheet. The process for reviewing your rap sheet is explained on Why You Should Review Your Rap Sheet There are three good reasons for obtaining a copy of your rap sheet:

- 1. You can check for mistakes.**

Rap sheets are often incomplete and contain mistakes that can make it harder to get a job if they are seen by an employer. You can correct errors before this happens if you review your record first. For example, if you were adjudicated award of the court when you were a juvenile (less than eighteen years of age), information concerning this adjudication can often be sealed. Once sealed, this information is confidential and should not be sent to an employer. Sometimes, as a result of a mistake, the ward of the court order still appears on the rap sheet after sealing. Information that should be confidential would then be sent to any employer who is authorized to see your record. If you notice the mistake ahead of time, you can make sure your juvenile ward of the court records remain confidential.

- 2. You may not remember everything.**

California law only permits employers to ask job applicants about some aspects of their criminal history. If you do not answer truthfully and completely and the employer finds out, you can be denied a job or fired. Because arrests and convictions may have occurred many years ago, you may not remember all the charges and the courts where you were tried, or even the charge you were convicted of. Therefore, it is important to review the specific details of your criminal history so that you can fill out job applications accurately. Also, court proceedings can be very confusing, and you may not fully understand the outcome of a case. For example, a person may plead guilty to misdemeanor charges and receive a conditional sentence, meaning that he or she does not have to pay a fine or serve time in jail. Even though there was no penalty, this is a conviction of a criminal offense that must be reported if a job application asks about criminal convictions. If you review your record before filling out a job application, you will be able to list your convictions accurately and not give misleading or false answers.

- 3. You can prepare for a job interview.**

While there are limitations on who can see your rap sheet, many employers and licensing agencies have legal access to your rap sheet, and other employers may obtain it unlawfully. Still others may ask you to list your criminal convictions. If you know exactly what your record reveals before you apply for a job or license, you'll have the opportunity to think about the best way to talk about your convictions with the job interviewer. For example, your record may report a conviction for a drug-related charge. An employer who sees this charge on your rap sheet might assume that you are currently a drug abuser. If you look at your record before your interview, you can be prepared to talk about this issue. You might then decide to present the employer with a letter from your drug treatment program as proof of your rehabilitation and recovery.

### **How To Read Your Rap Sheet**

Your rap sheet is divided into five vertical columns (see p. 8 for a sample rap sheet):

1. The left column contains the date of your arrest.
2. The second column lists the arresting agency.
3. Your name appears in the third column.
4. The fourth column contains the charge(s) on which you were arraigned. The charges will be summarized by a phrase (for example, "NARC CONTSUB FOR SALE," which means "narcotic controlled substance for sale"). This column also lists the corresponding citation in the California Penal Code (in this example, PC220.21) and sometimes the category of the offense (felony, misdemeanor, or violation). The number of counts is included, along with the notation "ATTEMPTED" if the offense was not completed.
5. The fifth column on the right is the most important section of your file. It is supposed to indicate the correct outcome or disposition of your charges. A complete disposition entry contains the date your case was heard, the name of the court, the index or docket number under which your case is filed, and the outcome of your case in court (for example, guilty plea entered, convicted after a trial, or acquitted). If you were convicted, the disposition column should also report the type of sentence or fine you received. If you were issued a Certificate of Rehabilitation, that would be indicated here. The sample rap sheet on p. 8 is annotated to help you find the above information, as well as other information you may need.

## What To Look For On Your Rap Sheet

The first thing you should do when you review your rap sheet is check it carefully for mistakes. Rap sheets may have one or more mistakes. The simplest explanation for this is that your case was handled by a number of different agencies: the arresting agency; the prosecutor's office; the court; the correctional facility; the probation or parole department; and DOJ. There are plenty of opportunities for part of your file to get lost or for someone to make an error at some stage of the process. Here are some common mistakes

### • Incomplete entries

Rap sheets often report arrests without stating the final disposition. When this happens, your rap sheet will say "no disposition reported" because no one informed DOJ about what happened to the case. An omission like this can be damaging because people who see your record might assume you were found guilty of the original arrest charges, when you may have been acquitted or convicted of less serious charges. Or people might assume that the charges are still outstanding and there is an open warrant for your arrest.

### • Incorrect entries

Any computer system is subject to human error. For example, a rap sheet could report that an individual was convicted of Burglary (section 461 of the California Penal Code) when, in fact, s/he had been arrested for and pled guilty to Assembly for the Purpose of Disturbing the Peace (section 416 of the Penal Code). A simple error made while typing in the penal code number could result in a terrible mistake. Check your rap sheet carefully to make sure that, as far as you can tell, all of the information is correct.

### • Double entries

Sometimes, information about one arrest will get split into two or more separate entries on your rap sheet. This mistake makes your criminal record look longer and more serious than it really is.

• **Cases that can be expunged, sealed, or purged, but are not altered or erased automatically.** However, some cases that can be purged should be purged automatically.

A violation of these section codes is a misdemeanor.

## Reducing a Felony to a Misdemeanor under P.C. § 17b

Only a criminal offense that is a wobbler can be reduced from a felony to a misdemeanor.

### What is a wobbler?

A wobbler is a criminal offense that can be charged either as a felony or a misdemeanor. To find out if a particular code section is a wobbler, go to <http://www.leginfo.ca.gov/calaw.html>. Check the Penal Code box and type in your code section at the search box at the bottom of the page.

Look to see if the criminal offense can result in state prison time (felony) OR a sentence of county jail/fine/probation (misdemeanor). If the punishment for the criminal offense can be either state prison time or a sentence of county/jail/fine/probation, then the criminal offense is a wobbler. If your conviction was charged as a felony and is a wobbler, you can get it reduced to a misdemeanor.

### EXAMPLE OF A WOBBLER:

P.C.487g...Every person who steals or maliciously takes or carries away any animal of another for purposes of sale, medical research, slaughter, or other commercial use, or who knowingly, by any false representation or pretense, defrauds another person of any animal for purposes of sale, medical research, slaughter, or other commercial use is **guilty of a public offense punishable by imprisonment in a county jail not exceeding one year or in the state prison**. Cal. Penal Code section 487g (2007).

### How do I reduce a felony to a Misdemeanor?

When a criminal offense is a wobbler, use Judicial Council form CR-180 (Petition and Order for Expungement) to both dismiss the conviction and to reduce the felony to a misdemeanor. A declaration and letters of support must accompany the petition because a petition to reduce a felony to a misdemeanor is discretionary.



# Criminal Records & Employment

KNOW YOUR RIGHTS

## 1. What exactly is a criminal record?

A criminal record, formally known as a **summary criminal history**, or more commonly known as a "rap" sheet, is a list of arrests and convictions. Any time the police fingerprint you because of a criminal investigation, that information is added to your summary criminal history. For an **arrest**, the history will list, among other things, the date, the charges, and the final disposition (what happened). If the district attorney refused to prosecute the charge, the summary criminal history should show that. The history also lists all your criminal **convictions**, including the date of the conviction, the charges, the sentence, and whether the crime was a felony or a misdemeanor. If you entered and successfully completed a "diversion" program, the history should indicate that as well.

## 2. How can I get my records if I cannot afford the fee?

If you cannot afford the fee, you may request a waiver. In your original letter or application, you must include a separate letter that requests a waiver of the fee. In the letter, you must state that you cannot afford the fee because you are poor, and you must include some proof that you are poor. To prove that you are poor, you may be able to simply explain how much you make a month and what your expenses are (rent and utilities) in the letter. If possible, you should include a copy of your pay stubs or bank accounts. Do NOT send original documents.

## 3. How do I read my summary criminal history?

The history will include your name, date of birth, and a list of all prior arrests and convictions. Most of the information will be clear. The history will list an abbreviation of the code sections of all charges and convictions. For example, if the history lists "H&S § 11359", the letters refer to the California Codes ("H&S" refers to the California Health and Safety Code—the code for most drug violations) and the number tells you the section identifying the crime in that code (for example, H&S § 11359 is possession of marijuana with intent to sell it). You can look up your code section at a law school or courthouse library.

## 4. Can I look up someone else's summary criminal history?

**No.** You can only request your own history. No other individual or person can request your history either.

## 5. Can my employer get my summary criminal history?

**Generally no.** Most private employers do NOT have the right to request your summary criminal history. In fact, unauthorized use of your private information is a crime. There are some important exceptions to this rule, mostly listed in Penal Code § 11105. Some of the most important exceptions are listed below:

- Law enforcement personnel, such as police officers or parole and probation officers, may see your summary criminal history if it is necessary for their jobs. People involved in a criminal case, such as court officers, judges, prosecutors, and defense attorneys, may see your summary criminal history if you are a party or a witness for a case.
- Government employers, like a job with the city or state, may see your summary criminal history in considering your application for a job if authorized by law or regulation. (Labor Code § 432.7.)
- Public utilities, especially nuclear power facilities, may be able to request your summary criminal history.
- Some organizations are considered "**agencies of the state**," and can see your records if permitted by law or regulation. This may include applications for licenses or certifications, such as entrance to the California bar or an application for a concessionaire's license. Some laws expressly allow other employers, such as **schools** or **eldercare agencies**, generally to see summary criminal history information to screen job applicants. To

have access under this exception, the law must (1) explicitly authorize the employer to see summary criminal history information, (2) refer to specific criminal conduct (i.e., specific crimes, not just any convictions), and (3) require that the employer act on the existence of such information. For example, the law might require the exclusion of job applicants with certain convictions, like child molestation, from certain jobs, such as teaching.

- Employers can also get access to some of your records (but not your “rap” sheet) through a general background check, using public record and databases kept by courts, news reporting agencies, or for-profit information-gathering services.

#### **6. Can my employer make me provide a copy of my summary criminal history record?**

**Normally, no.** With very few exceptions, your employer may NOT ask you to provide a copy of your summary criminal history. California Penal Code § 11126 and § 13326 make it a misdemeanor to request someone else’s summary criminal history records without authorization. If your employer is entitled to the information, she or he must request it directly from the appropriate agency, NOT from you.

#### **7. I was arrested but never charged. Will that arrest appear on my summary criminal history?**

**Probably.** The summary criminal history includes information on all arrests. Nonetheless, if you were arrested and either (1) not charged OR (2) not convicted, you may be able to seal your records. See California Penal Code § 851.8 (covering arrests of adults) or California Penal Code § 851.7 (covering arrests and misdemeanor convictions of minors). If your arrest (or conviction of a misdemeanor while a minor) has been sealed, the information should NOT appear in your summary criminal history. If it does, you may correct the records. To do so, see the section below titled “How do I correct mistakes in my summary criminal history?”

#### **8. I was convicted, but the conviction has been expunged. Will that conviction appear on my summary criminal history?**

**Yes.** Your record will list the original conviction, but then underneath that history, the record will state that the court has dismissed or set aside the charge. (See California Penal Code § 1203.4 for a description of the expungement process.)

#### **9. Can my employer ask me about arrests or use information about past arrests to fire me (or to not hire me)?**

**Generally not.** Under California Labor Code § 432.7, if you are applying for a job, or being considered for promotion, termination, or placement in a job training program, your employer cannot ask about any arrests that don’t result in a conviction, or any arrests that led to participation in a **diversion program** (such as drug rehabilitation). Your employer is also prohibited from trying to find out from other sources whether you have been arrested. If your employer somehow learns of your arrest record, § 432.7 prohibits him or her from considering any arrest that did not lead to a conviction, or any arrest that led to a diversion program, in making decisions regarding your hiring, firing or promotion.

There are some important exceptions to this general rule:

**Arrests pending trial:** An employer may ask you about any arrests that are pending trial, for which you are out on bail or your own recognizance. However, while your employer may generally inquire about any unresolved arrest, he or she may not rely on this as the sole determining factor in making an adverse decision to not hire or promote you.

- **Law enforcement positions:** Applicants to police departments, the Department of Justice, and other criminal justice agencies are not protected by the bar on arrest inquiries. However, current employees of these agencies are protected.

- **Health facility positions:** If the employer is a health care provider, and you are trying to obtain a position that has regular access to patients, the employer may ask if you were ever arrested (without conviction) for any of the sex crimes listed in California Penal Code § 290 (such as rape and incest). If you are applying for a job in which you will have access to drugs and medication, then the employer may ask you about past arrests for any of the drug offenses listed in California Health and Safety Code § 11590 (such as possession or sale), even if the arrests did not lead to conviction.



**10. Can my employer ask me about past convictions?**

**Generally, yes.** It is legal for your employer to ask about all convictions, including misdemeanors as well as felonies. However, employers normally ask only about past felonies.

**11. How do I correct mistakes in my summary criminal history?**

When you request your summary criminal history from the Department of Justice, they should automatically send you a correction request form along with your records. If you find something wrong with your records, fill out the form and return it to:

When you fill out the correction form, you must include certain information. First, you should describe as specifically as possible the information that is wrong or missing from your record. For example, if a charge had been dismissed and the record did not show that, you should indicate exactly which charge (use the code section), including the appropriate dates, when you make the request to have the dismissal included. Second, you should include a copy of any proof that will back up your request to change your record. Never send an original unless you are specifically told to, and if you do, keep a copy for yourself. Finally, always include your current return address in all letters to the Department of Justice.

**14. What does the Department of Justice do when I ask them to correct a record?**

When the Department of Justice receives your request for correction, it will first compare the information you sent with its own records (in other words, they check to see whether someone in their department simply made an error in typing your record into the computer). If the Department of Justice made a mistake, they will change your record and send you a copy of the new record.

If the information that you sent is different from the records the Department of Justice used to create your summary criminal history, the Department of Justice will send your new information to the agency that originally provided the records to the Department of Justice. (The Department of Justice created your record by taking any records of arrests and convictions received from other agencies.) For example, if you had been arrested in Alameda County, the Department of Justice would send your new information to Alameda County. The original agency must check its own records within thirty (30) days of receiving the new information from the Department of Justice. If the original agency agrees with you, it will correct your records and inform the Department of Justice.

Both agencies must notify anyone to whom they gave your records within the last ninety (90) days of the correction. If the original agency does not agree with you, you are entitled to an administrative hearing. The Department of Justice should provide you with information on how to request a hearing. At the hearing you will have a chance to present evidence about the mistake. The hearing judge decides whether or not to require that the agencies change the record.

**15. I tried to correct my summary criminal history, but the Department of Justice refused. What can I do now?**

If you lost in the administrative hearing, you have several options:

- You may, but do not have to, ask the agency to reconsider the decision.
- You may appeal to the courts through a writ of mandamus (per California Government Code § 11523). Filing a writ is very complicated. For information on how to file a writ, contact your local law library for a guide on filing "Writs & Receivers."
- You must appeal within thirty (30) days of the agency's decision becoming final.
- If you request your transcripts from the hearing within ten (10) days of the decision, you can receive an extension to file your court appeal until thirty (30) days after you have received the transcript.

**Consult the appropriate agency or an attorney about your rights.**

This fact sheet is intended to provide accurate, general information regarding legal rights relating to employment in California. ## Common Questions on Job Applications and Appropriate Responses

Here are some questions one may see on an employment application, and appropriate responses:

**Q: “Have you ever been arrested? If so, explain.”**

**A:** If a person has any arrests that resulted in a conviction, s/he should answer “yes.” (Remember, a guilty plea to any offense and/or crime is a conviction.) The person should list all misdemeanor convictions that have not been expunged or purged, all felony convictions that have not been expunged, and all infraction convictions. S/he should not list juvenile arrests or convictions.

If one has arrests, but none resulted in a conviction or the person successfully completed pretrial diversion, answer “no.” This is because it is illegal for most employers to ask about arrests that did not result in a conviction or for which pretrial diversion was successfully completed. By California law, one can answer “no” to an illegal question in this situation.

**REMINDER:** Even though one is not required to disclose expunged records for most private jobs, they are not erased from the record. One should, therefore, consider revealing them to any employer with access to rap sheets (see “Who Can See ‘Expunged’ Cases” on page 15 for more information). Also, one is required to list expunged or dismissed records in applications for public employment, public office or occupational licensure.

**Q: “Have you ever been convicted of a crime, offense, or violation of the law? If so, explain.”**

**A:** If one has any convictions, answer “yes.” List all misdemeanor convictions that have not been expunged or purged, and all felony convictions that have not been expunged. In addition, list all infraction convictions.

**Q: “Have you ever pled guilty or have been found guilty of a crime or an offense? If so, explain.”**

**A:** If one has any convictions, answer “yes.” List all misdemeanor convictions that have not been expunged or purged, and all felony convictions that have not been expunged. In addition, list all infraction convictions.

**Q: “Have you been convicted of a crime in the past 7 years? If so, explain.”**

**A:** If one has any criminal convictions within this period, answer “yes.” List all misdemeanor convictions that have not been expunged or purged, and all felony convictions that have not been expunged, that occurred during the past seven years. (Remember, traffic infractions are “offenses,” not crimes.) Keep in mind that one may have to explain cases in detail at an interview, so one will need to understand the charges for which one has been convicted. This means one should review the record and be able to **briefly** explain the circumstances underlying convictions, so that one can highlight all successes and accomplishments since then. Most important, one should provide evidence of rehabilitation that addresses the nature of the convictions. For example, if convictions were drug-related, one should provide reference letters from a treatment provider or counselor who can confirm successful recovery, and if a clergy, community, or family member who can say how the individual has changed.

## Certificate of Rehabilitation

How do I get a Certificate of Rehabilitation?

A certificate of rehabilitation generally allows a person convicted of a crime to have his or her civil and political rights of citizenship restored. The granting of a certificate of rehabilitation also serves as an application to the Governor for a pardon.

In order to qualify for a certificate of rehabilitation, a person must establish that he or she has lived an honest and upright life; that at least seven years have passed since the completion of the sentence, probation, or parole; there has been no further incarceration since his or her initial release from custody; and that he or she has resided in California for the past three years.

Individuals convicted of some crimes, such as those that carry mandatory life parole terms and certain sex offenses, are not eligible for a certificate of rehabilitation.

## Serve the Prosecuting Attorney

One copy of your Expungement petition is for the city or district attorney. One copy is for your files.

1. The law requires that the prosecuting agency get notice (also known as "service") of the filing of the petition at least 15 days before the judge hears your petition for an expungement. Service can be done in person, or by mail, by delivering a copy of the petition to the office of prosecuting attorney. The D.A. has an office at every criminal courthouse.
2. "Serving" the petition merely means that you hand-deliver or mail a copy of the petition to the city/district attorney's office.
3. Usually, the city attorney is notified for misdemeanor expungements, and the district attorney for felonies. If you are not sure, ask the clerk at the time you file your expungement petition.
4. You, as the defendant who is filing the expungement petition, cannot be the one to serve the D.A. or city attorney. You must have an adult who is 18 years of age or older serve the prosecuting Attorney.
5. Once the D.A. or city attorney has been served, you need to return to the court and request a "**Proof of Service**" form. The person who did the service should fill out the proof of service form and file it with the court. The form tells the judge that the prosecuting agency has been served as required by law. Without it, the judge cannot hear your petition for an expungement.

# **PETITION TO SEAL AND DESTROY ADULT ARREST RECORDS – 851.8**

## **NOTE: SEALING YOUR ARREST RECORD - IMPORTANT INFORMATION**

The standard to seal an arrest not leading to a conviction is factual innocence. This is a higher standard to meet than the standard for dismissing a conviction. Only go through this process if you can show that there was no reasonable cause to believe that you committed the act you were arrested for.

### **PETITIONER:**

Penal Code section 851.8 PC provides that a person who has been arrested or detained and is determined to be factually innocent may petition the law enforcement agency or the court having jurisdiction over the matter to provide for the sealing and destruction of the record of that arrest. Petitions concerning arrests occurring on or after January 1, 1981, or accusatory pleadings filed on after January 1, 1981, may be filed for up to two years following the arrest filing date. Until January 1, 1983, petitions can be filed for arrests which occurred or accusatory pleadings which were filed up to five years prior to the statute's effective date of September 29, 1980.

### **PETITION THE ARRESTING AGENCY (851.8(a) PC**

Penal Code section 851.81(a) PC provides in part: "In any case where a person has been arrested and no accusatory pleadings has been filed, the person arrested may petition the law enforcement agency having jurisdiction over the offense to destroy its record of the arrest. A copy of such petition shall be served upon the district attorney of the county having jurisdiction over the offense."

### **PETITION DENIED OR NO RESPONSE TO PETITION (851.8(b) PC**

Penal Code section 851.8(b) PC provides in part: "If, after receipt by both the law enforcement agency and the district of a petition for relief under subdivision (a), the law enforcement agency and district attorney do not respond to the petition by accepting or denying such petition within 60 days after the running of the relevant statute of limitations or within 60 days after receipt of the petition in cases where the statute of limitations has previously lapsed, then the petition shall be deemed to be denied. In any case where the petition of an arrestee to the law enforcement agency to have an arrest record destroyed is denied, petition may be made to the municipal or justice court. A copy such petition shall be served on the district attorney of the county having jurisdiction over the offense at least 10 days prior to the hearing." Note: the petitioner shall be responsible for obtaining the original petition from the law enforcement agency and submission to the court of

### **PETITION TO THE COURT OF JURISDICTION (851.8(C)**

Penal Code section 851.8(c) provide in part: "In any case where a person has been arrested, and an accusatory pleading has been filed, but where no conviction has occurred, the defendant, may, at any time after dismissal of the action, petition the court which dismissed the action for a finding that the defendant is factually innocent of the charges for which the arrest was made. A copy of such petition shall be served on the district attorney of the county in which the accusatory pleading was filed at least 10 days prior to the hearing on the petitioner's factual innocence."

It is the responsibility of the petitioner to submit any declarations, affidavits, police reports or other evidence, which may exist to support the petition to appropriate the arresting agency or court and to serve a copy of the petition and supporting papers on the district attorney.

# WANT TO SEAL YOUR JUVENILE DELINQUENCY RECORD?



## HOW TO:

Seal your Juvenile Delinquency Record.

## WHEN TO USE:

Five years after your juvenile case has been dismissed or you are at least 18 years of age and not currently on juvenile or adult

2. You must not have any outstanding law violations or warrants as an adult or juvenile. If you are currently awaiting court as an adult or you are currently on adult probation, you are not eligible for juvenile record sealing until you complete your probation term.
3. You must pay in full all previous fines or restitution owed to the Court as an adult or juvenile, including any traffic fines.
4. You must not be currently involved in any civil litigation or pending any civil litigation arising from any of the offenses, which you are attempting to have sealed.
5. Convictions as an adult, for any felony or for a misdemeanor involving moral turpitude (theft, false information to a police officer, etc.), will result in your Petition for Record Sealing to be denied by the Juvenile Court.
6. The Juvenile Court cannot seal the records of a minor in any other state. If you have a juvenile record in another state, you must apply to that state for sealing.

### Other Considerations:

- While traffic records may be sealed, insurance companies, by law, are given access to traffic (DMV) records for the purpose of determining eligibility for auto insurance, and/or setting insurance rates (Welfare and Institutions Code 781).

- If the Court found that you committed an offense listed in Section 707(b) of the Welfare and Institutions Code after you turned 14 years of age, you may not apply to have your record sealed. If you are in doubt as to whether your offense was a 707(b) offense, you may contact the Probation Department at 408-278-6045 for assistance. The Court generally looks for an arrest free record for a period of time after your case was dismissed or closed to satisfy this requirement.

It is strongly recommended you not apply for record sealing for approximately nine months after your case has been dismissed by the Court or closed by the Probation Department, even if you have already turned 18. Also, do not apply too soon as the Judge may deny your request for record sealing.





## HOW TO FILE YOUR EXPUNGEMENT PAPERS

Follow these easy steps in order from 1 to 5.

1. Attached to this information packet is the Juvenile Record Sealing Application. Follow the attached sample.
2. You must complete the top portion of the form. Complete the rest of the form to the best of your knowledge. The Court is mainly concerned with the name of the law enforcement agencies that arrested or cited you. Sign the bottom of the second sheet and include your address.
3. There is a required \$70.00 application fee. You may either submit a check or money order made payable to the "Probation Department".
4. You can either mail or deliver in person the check or money order and completed forms to:

5. Generally the process takes five to six months because of the investigation process that must be done on your request for record sealing

After submitting your Juvenile Record Sealing Application, you do not need to appear in Court. The process is done by a Probation Officer and submitted to a Judge of the Juvenile Court who then grants or denies the petition.

- You will receive a copy of the Order from the Court either granting or denying the Petition for Record Sealing by mail. If your petition is denied, you will not receive a refund of your application fee.

### What's Next?

- Pursuant to Welfare and Institutions Code 781, once the Court has ordered the person's records sealed, the proceedings in their case shall be deemed never to have occurred, and the person may properly reply accordingly to any inquiry about the events, the records of which are ordered sealed.

## INFORMATION SHEET ON WAIVER OF SUPERIOR COURT FEES AND COSTS

If you have been sued or if you wish to sue someone, or if you are filing or have received a family law petition, and if you cannot afford to pay court fees and costs, you may not have to pay them in order to go to court. If you are getting public benefits, are a low-income person, or do not have enough income to pay for your household's basic needs *and* your court fees, you may ask the court to waive all or part of your court fees.

1. To make a request to the court to waive your fees in superior court, complete the *Request to Waive Court Fees* (form FW-001). If you qualify, the court will waive all or part of its fees for the following:
  - Filing papers in superior court (other than for an appeal in a case with a value of over \$25,000)
  - Making and certifying copies
  - Sheriff's fee to give notice
  - Court fees for telephone hearings
  - Reporter's daily fee (*for up to 60 days after the grant of the fee waiver, at the court-approved daily rate*)
  - Preparing, certifying, copying, and sending the clerk's transcript on appeal.
  - Giving notice and certificates
  - Sending papers to another court department
  - Having a court-appointed interpreter in small claims court
2. You may ask the court to waive other court fees during your case in superior court as well. To do that, complete a *Request to Waive Additional Court Fees (Superior Court)* (form FW-002). The court will consider waiving fees for items such as the following, or other court services you need for your case:
  - Jury fees and expenses
  - Fees for court-appointed experts
  - Reporter's daily fees (*beyond the 60-day period after the grant of the fee waiver, at the court-approved daily rate*)
  - Fees for a peace officer to testify in court
  - Court-appointed interpreter fees for a witness
  - Other necessary court fees
3. If you want the Appellate Division of Superior Court or the Court of Appeal to review an order or judgment against you and you want the court fees waived, ask for and follow the instructions on *Information Sheet on Waiver of Appellate Court Fees, Supreme Court, Court of Appeal, Appellate Division* (form APP-015/FW-015-INFO).

### IMPORTANT INFORMATION!

- **You are signing your request under penalty of perjury. Please answer truthfully, accurately, and completely.**
- **The court may ask you for information and evidence.** You may be ordered to go to court to answer questions about your ability to pay court fees and costs and to provide proof of eligibility. Any initial fee waiver you are granted may be ended if you do not go to court when asked. You may be ordered to repay amounts that were waived if the court finds you were not eligible for the fee waiver.
- **If you receive a fee waiver, you must tell the court if there is a change in your finances.** You must tell the court within five days if your finances improve or if you become able to pay court fees or costs during this case. (File *Notice to Court of Improved Financial Situation or Settlement* (form FW-010) with the court.) You may be ordered to repay any amounts that were waived after your eligibility came to an end.
- **If you receive a judgment or support order in a family law matter:** You may be ordered to pay all or part of your waived fees and costs if the court finds your circumstances have changed so that you can afford to pay. You will have the opportunity to ask the court for a hearing if the court makes such a decision.
- **If you win your case in the trial court:** In most circumstances the other side will be ordered to pay your waived fees and costs to the court. The court will not enter a satisfaction of judgment until the court is paid. (This does not apply in unlawful detainer cases. Special rules apply in family law cases. (Government Code, section 68637(d), (e).))
- **If you settle your civil case for \$10,000 or more:** Any trial court waived fees and costs must first be paid to the court out of the settlement. **The court will have a lien on the settlement in the amount of the waived fees and costs.** The court may refuse to dismiss the case until the lien is satisfied.
