The Emergency Department Assistant (EMT-1) Overview

The Emergency Department Assistant program consists of two modules: Module 10A (lecture) and module 10B (lab) must be taken concurrently. Upon the successful completion of this course and through adherence to the Department of Transportation (DOT) basic life support curriculum, the student will be eligible to take the National Registry EMT certification examination. A valid American Heart Association Healthcare Provider BCLS card must be presented on the first day of class.



Emergency Department Assistant Course Description

10- EMERGENCY MEDICAL TECHNICIAN 1: MODULE A (6 units); MODULE B (2 units)

This course is offered in two modules. Module A (lecture) and Module B (Lab) must be taken concurrently. Recommended Preparation: For Module A, eligibility for English 101. Module A meets two times a week and Module B meets once a week.

What type of work can I do as an EMT? Some of the tasks include but are not limited to the following:

- Administer first aid treatment or life support care to sick or injured persons in pre-hospital settings.
- Perform emergency diagnostic and treatment procedures, such as stomach suction, airway management, or heart monitoring, during ambulance ride.
- Observe, record, and report to physician the patient's condition or injury, the treatment provided, and reactions to drugs or treatment.

- Immobilize patient for placement on stretcher and ambulance transport, using backboard or other spinal immobilization device.
